92Q'S "JIM JEFFERIES OPEN TEXT" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WQQKF-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.92qnashville.com, or by sending a self-addressed, stamped envelope to the above address.

All entries must be received by 11:59pm CT on April 6, 2025, to be eligible for the Prize drawing. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes.
