## 92Q "D&K MENSWEAR 92Q SPRING WEB" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WQQK-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.92qnashville.com, or by sending a self-addressed, stamped envelope to the above address.

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59pm CT on April 27, 2025, to be eligible for the Prize drawing. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified.
